

Terms and Conditions of the "Invite a Friend" Promotion

1. OZIOS is registered brand name of APME FX TRADING EUROPE LTD. (hereinafter "Company") announces a promotion for Clients titled "Invite a Friend," under which the Client as well as the person who becomes a client of the Company based on the Client's invitation will receive a reward, all in accordance with the conditions set out in this document (hereinafter referred to as the "Invite a Friend" promotion).
2. The Client may participate in the Invite a Friend promotion only if they have an open Client account with the Company.
3. Participation in the Invite a Friend promotion is as follows:
 - a) The Client invites another natural person, different from the Client and who is not a client of the Company, and who subsequently fulfills the conditions stated herein (hereinafter referred to as the "Friend") by delivering to the Friend their promo code generated in Myzone on the Platform,
 - b) The Friend enters the promo code received from the Client during their registration on the Platform,
 - c) The Friend subsequently becomes a Client in accordance with the agreement between the Friend and the Company or the General Terms and Conditions and opens a Client account on which they will trade instruments other than Contracts for Difference (CFDs),
 - d) The Friend deposits at least EUR 1,000 into their Client account on which they will trade instruments other than Contracts for Difference (CFDs),
 - e) The Friend executes a trade on the Client account according to letter d).
4. If the Client and the Friend cumulatively meet all conditions specified in point 3, each of them will receive a reward of EUR 200, which the Company will credit to each of them in the form of randomly chosen stock to their Client accounts on which they trade instruments other than Contracts for Difference (CFDs) (hereinafter referred to as the "Reward").
5. For the avoidance of doubt, if the Friend fails to meet even one of the conditions specified in point 3, neither the Client nor the Friend will receive the Reward.
6. The Client and the Friend may withdraw the Reward from the Client account to their bank account; however, they may not transfer the Reward to a Client account on which they trade Contracts for Difference (CFDs).

7. The Client must not publicly distribute the promo code, which means, in particular, addressing an indefinite number of persons with an offer to participate in the Invite a Friend promotion under these conditions, or offering the promo code to an indefinite number of persons in any form.
8. The Client may invite an unlimited number of friends.
9. The Friend may participate in the Invite a Friend promotion as a Friend only once. After the Friend becomes a Client, they may participate in the Invite a Friend promotion as a Client under the conditions set out in this document.
10. The Client and the Friend acknowledge that the Company may refuse to accept the Friend as a Client for reasons specified in the General Terms and Conditions or for reasons arising from Applicable Regulations or from the Company's internal procedures and rules.
11. The Company may withdraw the Reward from the Client or the Friend if it finds that they, jointly or individually, acted in violation of Applicable Regulations, in a fraudulent or dishonest manner, or if they fail to comply with or abuse the conditions of the Invite a Friend promotion.
12. The Invite a Friend promotion does not constitute any form of investment advice or investment research, nor an offer of any transaction involving a financial instrument.
13. The Client and the Friend are obliged to familiarize themselves with these conditions before participating in the Invite a Friend promotion and to accept these conditions. By participating in the Invite a Friend promotion, the Client as well as the Friend agree to these conditions and confirm that they have participated in the promotion voluntarily.
14. The amount corresponding to the Reward may be subject to withholding income tax at the rates applicable at the time the Reward is transferred to the Client account, in accordance with Applicable Regulations. If, under Applicable Regulations, the Company is required to withhold withholding tax from the amount of the Reward, the Company will proceed accordingly, and the Client and the Friend acknowledge this. The Company may therefore debit from the Client account an amount corresponding to the withholding tax on the Reward. If the Client or the Friend is a non-resident, the Reward may be subject to income taxation under the legal regulations applicable in the country in which the non-resident (Client or Friend) is domiciled. The Company is not responsible for the proper settlement of any tax by a non-resident Client or Friend in the country of their tax domicile.
15. The Invite a Friend promotion and these conditions are valid and effective from 13.5.2025.
16. The Company may terminate the Invite a Friend promotion at any time without stating a reason. The termination of the Invite a Friend promotion will be announced by the Company via the website www.ozios.com. If the Client or the Friend demonstrably performed any action within the process of inviting the Friend under these conditions before the date of

termination of the Invite a Friend promotion according to the previous sentence, the Invite a Friend promotion will continue to apply to such Client and Friend.

17. The Reward is not available for clients from Romania, Portugal, Poland and Spain.
18. For the avoidance of doubt, terms used in these conditions with a capital initial letter have the same meaning as defined in the agreement between the Client and the Company or in the Company's General Terms and Conditions.
